TITLE: Approve Contract for Concrete Flatwork Sidewalks, Curbs, Gutters & Related Items-Countywide

I. MOTION REQUESTED

A) Award Invitation to Bid No. B190074JJB, Concrete Flatwork: Sidewalks, Curbs, Gutters and other Related Items – Annual, to the following responsive and responsible vendors for an initial period of one year, to provide repair and/or replacement of concrete sidewalks, curbs, as approved in the departments' annual adopted budgets: BRT Development, LLC d/b/a Titan Foundations and Grading; Neubert Construction Services, Inc.; Pavement Maintenance, LLC; Scott Commercial Contracting, LLC and Villa-Fuerte Construction, LLC. Individual projects with a cost of \$100,000.00 or more shall be brought back to the Board for approval.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contracts for up to three additional one-year periods, and to execute all associated documents as approved by the departments' annual adopted budgets, if doing so in the best interest of Lee County and there are no cost increases associated with the renewals.

II. ITEM SUMMARY

Awards contracts to BRT Development, LLC d/b/a Titan Foundations and Grading; Neubert Construction Services, Inc.; Pavement Maintenance, LLC; Scott Commercial Contracting, LLC and Villa-Fuerte Construction, LLC to perform repair and/or replacement of concrete to include but not limited to: concrete removal, concrete sidewalks, curbs and gutters, driveways, gravity wall, and other concrete repair. This was a new solicitation resulting in a new annual contract. Annual expenditures are anticipated not to exceed \$3,000,000.00. Individual projects with a cost of \$100,000.00 or more shall be brought back to the Board for approval.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

On December 17, 2018, the Lee County Department of Transportation (DOT) submitted a request to Procurement Management to obtain bids to contract with vendors to perform concrete flat work, sidewalks, curbs, gutters and other related items. On April 23, 2019, Procurement Management advertised Invitation to Bid. B190074JJB, Concrete Flat Work, Sidewalks, Curbs, Gutters and other Related Items – Annual.

On the bidding deadline May 23, 2019, Procurement Management received six bids. Lee County DOT and Procurement Management reviewed the bids and it was recommended that contracts are awarded to all six vendors, who were determined to be responsive and responsible: BRT Development, LLC d/b/a Titan Foundations and Grading; Neubert Construction Services, Inc.; Pavement Maintenance, LLC; Scott Commercial Contracting, LLC and Villa-Fuerte Construction, LLC. Annual expenditures are anticipated not to exceed \$3,000,000.00.
