

FIRST AMENDMENT OF ANNUAL AGREEMENT FOR GRANULAR ACTIVATED
CARBON (GAC) AND ABSORBTION/FILTRATION SERVICES

THIS FIRST AMENDMENT OF THE ANNUAL AGREEMENT FOR GRANULAR ACTIVATED CARBON (GAC) AND ABSORBTION/FILTRATION SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Calgon Carbon Corporation, ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of Granular Activated Carbon (GAC) and absorption/filtration services through Solicitation B190100GWT with Vendor on the 13th day of May, 2019 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the cost per pound for purchasing the removal, supply and installation of virgin Granular Activated Carbon (GAC) from the Vendor; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 7th day of May, 2022; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XVI. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:
