

FIRST AMENDMENT OF THE AGREEMENT

THIS FIRST AMENDMENT OF THE AGREEMENT FOR IRRIGATION PARTS AND RELATED ITEMS, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Heritage Landscape Supply Group, Inc. dba FIS Outdoor ("Vendor"), collectively, the "Parties."

WHEREAS, the County executed an Agreement for the purchase of irrigation parts and related items through Solicitation B190118KLC with Vendor on the 1<sup>st</sup> day of April, 2019 ("Agreement");

WHEREAS, on the date the Agreement was executed, the Vendor's business entity name was Florida Irrigation Supply, Inc. dba FIS Outdoor with a Federal Tax ID Number of 59-1522565; and,

WHEREAS, after execution of the Agreement, Florida Irrigation Supply, Inc. dba FIS Outdoor was acquired by, and merged with, Heritage Landscape Supply Group, Inc., with a Federal Tax ID Number of 46-1116383; and,

WHEREAS, County and Vendor desire to enter into this First Amendment to continue their Agreement via Solicitation No. B190118KLC under the Vendor's new business name.


