

SECOND AMENDMENT TO AGREEMENT FOR LANDSCAPE MAINTENANCE  
AND MOWING FOR DOWNTOWN BUILDINGS - ANNUAL

THIS SECOND AMENDMENT TO AGREEMENT FOR LANDSCAPE MAINTENANCE AND MOWING FOR DOWNTOWN BUILDINGS - ANNUAL, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and LeeCount, LLC dba US Lawns of Fort Myers, ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for landscape maintenance and mowing services for downtown buildings, with Vendor on the 29<sup>th</sup> day of October, 2019 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Vendor's business entity name was Landscape Dimensions, Inc., with a Federal Tax ID Number of 26-0375343; and,

WHEREAS, after execution of the Agreement, Landscape Dimensions, Inc., was acquired by Stelissa, Inc., dba US Lawns of Fort Myers, with a Federal Tax ID Number of 47-4584230; and,

WHEREAS, the County entered into the First Amendment of the Agreement to assign the Agreement from Landscape Dimensions, Inc. to Stelissa, Inc., dba US Lawns of Fort Myers; and,

WHEREAS, after execution of the First Amendment, Stelissa, Inc., dba US Lawns of Fort Myers, was acquired by LeeCount, LLC dba US Lawns of Fort Myers, with a Federal Tax ID Number of 87-4656855; and,

WHEREAS, County and Vendor desire to enter into this First Amendment to continue their Agreement for landscape maintenance and mowing services under the Vendor's new business entity.


NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, LeeCount, LLC dba US Lawns of Fort Myers, shall continue to supply such services in accordance with the terms, conditions, and specifications of the Agreement, including appendices and amendments, and Vendor's response.
