WHEREAS, after execution of the First Amendment of the Agreement, Blu Site Solutions of Southwest Florida, Inc., with a Federal Tax ID Number of 20-4186602, was rebranded as Toi Toi USA, LLC, with a Federal Tax ID Number of 92-10003772; and,

WHEREAS, County and Vendor desire to enter into this Second Amendment to continue their Agreement via Solicitation No. B190369RJD under the Vendor's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, conducting business as Toi Toi USA, LLC, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. B190369RJD, including appendices and amendments, and Vendor's response.
