FIRST AMENDMENT OF THE ANNUAL AGREEMENT FOR THE PURCHASE OF SULFURIC ACID - ANNUAL, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Sulphuric Acid Trading Company, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the annual purchase of 93.19% - 95% sulfuric acid through Solicitation No. B200253AEJ with Vendor on the 10<sup>th</sup> day of August, 2020 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the price for the annual purchase of 93.19% - 95% sulfuric acid; and,

WHEREAS, the Parties mutually agree that the price increase will begin on the 4<sup>th</sup> day of August, 2023; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

- 1. The price increase will begin on the 4th day of August, 2023
- 2. The Parties agree that the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:
