TITLE: Approve Contract Amendment for Lubricant Products - Countywide

I. MOTION REQUESTED

A) Approve Amendment No. 1 with Palmdale Oil Company, Inc., under Solicitation No. B210268LLP, Lubricant Products, to increase the price for the purchase of various lubricant products under Category 9 – Diesel Exhaust Fluids, in accordance with the amended Fee Schedule

B) Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approves a contract amendment with Palmdale Oil Company, Inc., under the solicitation for Lubricant Products, to increase the price for the purchase of various lubricant products in Category 9 – Diesel Exhaust Fluids, in accordance with the amended fee schedule. The price increase is due to increased market rates for these types of products. The price for diesel exhaust fluid per gallon increased from \$1.35 to \$2.66 and the price per gallon of the 55-gallon drum increased from \$3.18 to \$6.24. Total expenditures during Fiscal Year 2021-2022 were approximately \$82,747.49.

On October 19, 2021, the Board of County Commissioners awarded B210268LLP, Lubricant Products, to Palmdale Oil Company, Inc. to provide lubricant products, on an as needed basis. The original term of the contract was for three years with an option to renew three additional years.
