FIRST AMENDMENT OF AGREEMENT FOR PURCHASE OF PESTICIDES, FUNGICIDES & HERBICIDES

THIS FIRST AMENDMENT OF THE AGREEMENT FOR PURCHASE OF PESTICIDES, FUNGICIDES & HERBICIDES, is made by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and SiteOne Landscape Supply, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of pesticides, fungicides & herbicides, through Solicitation B220088WCD, with Vendor on the 7th day of July, 2022 ("Agreement"); and,

WHEREAS, it was discovered after the execution of the Agreement that there was a clerical error on one product's unit of measure and also an incorrect price bid by the Vendor for a different item in the Exhibit B. Fee Schedule, which the Vendor cannot maintain; and,

WHEREAS, the Parties desire to modify the Exhibit B. Fee Schedule, pursuant to Article XV. Miscellaneous of the Agreement, to correct the unit of measure for the Pesticide-Insecticide product, Item #2, Arena 50, from gallon to ounce and remove the bid for the Herbicide product, Item #42 Reward (Aquatic).

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

 The Parties agree that Exhibit B. Fee Schedule for the Vendor shall be superseded by the following:
