#### I. MOTION REQUESTED

A) Award Invitation to Bid No. B220088WCD, Purchase of Fungicides, Herbicides & Pesticides for the purchase and delivery of pesticides, fungicides & herbicides on an as needed basis, for an initial term of one year, as approved in the departments' annual adopted budgets and awarded to the following vendors: Heritage Landscape Supply dba FIS Outdoor, Mar Green Resources, LLC, SiteOne Landscape Supply, and Winfield Solutions.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contracts for up to three additional one-year periods, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewals.

#### II. ITEM SUMMARY

Awards contracts to Heritage Landscape Supply dba FIS Outdoor, Mar Green Resources, LLC, SiteOne Landscape Supply, and Winfield Solutions to provide the supply and delivery of pesticides, fungicides & herbicides to County departments, on an as-needed basis for an initial one-year period as approved in the departments' annual budgets. The contracts can be renewed for up to three additional one-year periods, upon the agreement of all parties. Total expenditures for these services for Fiscal Year 2020-2021 was \$97,106.54.00.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

Procurement Management obtained bids for the project known as Invitation to Bid No. B220088WCD, Purchase of Pesticides, Fungicides & Herbicides. On the bid deadline of March 2, 2022, Procurement Management received five submittals. After conducting an analysis of the bid submissions, Heritage Landscape Supply dba FIS Outdoor, Mar Green Resources, LLC, SiteOne Landscape Supply, and Winfield Solutions were determined to be the responsible and responsive bidders.

Staff recommends awarding contracts to Heritage Landscape Supply dba FIS Outdoor, Mar Green Resources, LLC, SiteOne Landscape Supply, and Winfield Solutions for use on an as-needed basis.
