TITLE: Approve Contract Amendment for Quicklime for Corkscrew Water Treatment Facility

#### I. MOTION REQUESTED

A) Approve Amendment No. 1 with Lhoist North America of Alabama, LLC, under Solicitation No. B220105CMR, Quicklime - Annual, to increase the price for the annual purchase of Quicklime as provided on the Amendment Fee Schedule.

B) Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

### II. ITEM SUMMARY

Increases prices for Quicklime from Lhoist North America of Alabama, LLC, to \$420.83 per ton from \$365.94. The price increase is due to increased production and shipping costs. Quicklime is used at the Corkscrew Water Treatment Plant for a coagulation process that removes hardness ions through precipitation. Total expenditures for the prior 12 month-period were \$966,546.89.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

### A) Board Action and Other History

On April 5<sup>th</sup>, 2022, the Board of County Commissioners awarded B220105CMR, Quicklime -Annual, to Chemrite, Inc. as the primary vendor and Lhoist North America of Alabama, LLC as the secondary vendor for the purchase and supply of Quicklime on an sa-needed basis. The original term of the contract was for one (1), three (3) year period with an option to renew for up to three (3) additional years.

On May 5<sup>th</sup>, 2022, Chemrite Inc. withdrew from the agreement stating they could no longer provide the product as agreed upon.

Current Board approval will allow for the price increase of 15% to Lhoist North America of Alabama.

## D) Analysis

Lhoist originally submitted a request for a price increase of 17%, and Procurement Management negotiated a 15% price increase for a 2% savings to the county. Vendor cited that they are receiving increases in energy and fuel used to produce lime products. Other energy market related-increases include subcontracting, diesel, additives, and railroad shipping. A price increase of 15% is estimated to add an additional \$144,982.03 per twelve month spend, as detailed in the Historical Pricing Summary table. This product is used at the Corkscrew Water Treatment Plant for lime softening as the primary treatment process. Lime is used in the coagulation process to remove hardness ions through precipitation.
