

## FIRST AMENDMENT OF AGREEMENT FOR TEMPORARY PERSONNEL SERVICES

THIS FIRST AMENDMENT OF THE AGREEMENT FOR TEMPORARY PERSONNEL SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Employbridge Holding Company DBA Remedy Intelligent Staffing, ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of temporary personnel services on an as needed basis through Solicitation B220182CMR with Vendor on the 31<sup>st</sup> day of May, 2022 ("Agreement"); and,

WHEREAS, after the execution of the Agreement it was determined that it would be in the best interest of the County to include proposed pricing for the purchase of temporary personnel services from the Vendor, in the Exhibit B Fee Schedule of the Agreement, for the potential remaining renewal contract years; and,

WHEREAS, pursuant to Article XIV. MISCELLANEOUS of the Agreement, the Parties desire to modify the Agreement to add the additional pricing, for the remaining contract years, to the Exhibit B. Fee Schedule of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties also agree that the Exhibit B. Fee Schedule of the Agreement shall be superseded by the following:
