

FIRST AMENDMENT OF AGREEMENT FOR TEMPORARY PERSONNEL SERVICES

THIS FIRST AMENDMENT OF THE AGREEMENT FOR TEMPORARY PERSONNEL SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Precision Staffing, Inc., ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of temporary personnel services on an as needed basis through Solicitation B220182CMR with Vendor on the 31st day of May, 2022 ("Agreement"); and,

WHEREAS, after the execution of the Agreement it was determined that it would be in the best interest of the County to include proposed pricing for the purchase of temporary personnel services from the Vendor, in the Exhibit B Fee Schedule of the Agreement, for the potential remaining renewal contract years; and,

WHEREAS, after the execution of the Agreement it was determined that it would be in the best interest of the County to add a "Day Laborer for DOT" position to the Exhibit A. Scope of Work and Specifications section of the Agreement and corresponding pricing for the "Day Laborer for DOT" position, in the Exhibit B. Fee Schedule of the Agreement; and,

WHEREAS, pursuant to Article XIV. MISCELLANEOUS of the Agreement, the Parties desire to modify the Agreement to add the proposed additional pricing, for the remaining renewal contract years, to the Exhibit B. Fee Schedule of the Agreement, and to add the "Day Laborer for DOT" position to the Exhibit A. Scope of Work and Specifications section of the Agreement and corresponding pricing for the "Day Laborer for DOT" position, in the Exhibit B. Fee Schedule of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

5.7 FOR DOT OPERATIONS –Ability to take direction from lee County Staff. Ability to do litter pickup on Lee County Roadways. Litter pickup and maintaining of canal banks to include weed whacking and mowing. Loading and unloading of litter truck to the appropriate land fill area. Sweeping and general cleaning of buildings, as necessary.






