Scope of Work and Specifications section of the Agreement and corresponding pricing for the "Day Laborer for DOT" position, in the Exhibit B. Fee Schedule of the Agreement; and,

WHEREAS, pursuant to Article XIV. MISCELLANEOUS of the Agreement, the Parties desire to modify the Agreement to add the additional pricing, for the remaining contract years, to the Exhibit B. Fee Schedule of the Agreement, to correct the Mark-Up amount listed in Option A of the Exhibit B Fee Schedule, and to add the "Day Laborer for DOT" position to the Exhibit A. Scope of Work and Specifications section of the Agreement and corresponding pricing for the "Day Laborer for DOT" position, in the Exhibit B.
