#### **PRICING**

This is a “Master” contract, which is not for any specific project. Work will be negotiated, authorized, scheduled, funded, and accounted for by the issuance of County Project Authorizations (CPA), by the requesting department, division or other governmental entity. The County’s intent is to award to a pool of Contractors who meet the minimum criteria and qualifications. **Each project/task order will not exceed \$500,000.00.**

#### **PROJECT/TASK ORDER**

1. **Each project/task order will not exceed \$500,000.00.**
  - 1.1. Any project/task with a total cost of **\$50,000.00 or less** may be awarded to any firm holding a valid contract under this bid able to meet the required project schedule.
  - 1.2. Any project/task with a total cost of **\$50,000.01 or greater, but less than \$500,000.00** shall be quoted by a minimum of three (3) of the approved firms holding a valid contract under Solicitation No. B220257ACN. If there are fewer than three (3) approved firms holding a valid contract under Solicitation No. B220257ACN, then all of the firms shall quote the project/task. When quotes are requested, the Contractor’s submittal shall be based on the unit prices contracted, or lower prices. The quote shall not list any prices that are higher. Award of the project shall be made to the firm holding a valid contract under Solicitation No. B220257ACN, with the lowest quoted price, and able to meet the required project schedule.
  - 1.3. Any project/task order **over \$200,000.00 or more** shall require a Payment and Performance Bond to be executed for the full value of the project and recorded by the Lee County Clerk of Courts.
  - 1.4. The County retains the right to separately and competitively bid any and all job estimates greater than \$500,000.00.
  - 1.5. Contractor shall be responsible for providing all equipment necessary to complete services as requested under this Agreement.
