## MOTION REQUESTED

A) Award Invitation to Bid No. B220306CMR, Olga WTP Sludge Removal & Disposal to C&M Dredging, Inc. as a Primary Vendor and Synagro South, LLC as a Secondary Vendor for the alum removal of 4 lagoons at the Olga Water Treatment Plant, on an as-needed basis, for an initial term of one (1) three (3) year period, as approved in the departments' annual adopted budget. Singular purchases in excess of \$100,000.00 will be presented to the Board for approval.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contracts for up to (3) three additional years and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal.

#### II. ITEM SUMMARY

Awards competitively bid contracts to C&M Dredging, Inc. as the primary vendor and Synagro South, LLC as the secondary vendor for sludge removal and disposal at the Olga Water Treatment Plant. The initial contract is for a three-year period, with an option to renew for up to three additional years. Sludge is a byproduct created during the water treatment process, which is then transferred into four holding ponds that must be cleaned to maintain normal operations. Total expenditures for the prior twelve-month period were \$179,700.00.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

#### A) Board Action and Other History

Procurement Management obtained bids for the project, known as Invitation to Bid No. B220306CMR, Olga WTP Sludge Removal & Disposal. On the bid deadline of June 3, 2022, Procurement Management received seven bids. After analyzing the seven bid submittals, C&M Dredging, Inc. and Synagro South, LLC were determined to be the lowest responsive and responsible bidders.

Sludge is a byproduct of the water treatment process at the Olga Water Treatment. Aluminum sulfate and polymer are used in the coagulation process to precipitate out organic material and for color removal of the raw water. This process creates a sludge that is wasted and transferred to four holding ponds in preparation for disposal.
