TITLE: Award Contract for Mobile Waste Tire Shredding Services

I. MOTION REQUESTED

- A) Award Invitation to Bid No. B220524CMR – Mobile Waste Tire Shredding Services to Atlantic Can Inc for mobile tire shredding services, on an as needed basis, for an initial term of one (1) with three (3) year renewal options, as approved in the departments’ annual adopted budget.
- B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C) Grant the County Manager or designee the authority to renew the contracts for up to (3) three additional years and to execute all associated documents, as approved in the departments’ annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal.

II. ITEM SUMMARY

Awards an annual contract to Atlantic Can Inc. with a three year renewal option to provide mobile waste tire shredding services for the Solid Waste Department. Work includes mobilization of shredding equipment, size reduction and shredding of waste tires, on an as needed basis, at the department’s existing permitted waste tire management site. At \$90 per ton this allows the Solid Waste Department to move over 1,000 tons of tires out of the Waste-to-Energy plant, saving space for municipal solid waste. This is a new contract with no previous spending. FY23 Budget - \$300,000.

Provides an alternative method to manage waste tires. The department receives approximately 9,000 tons annually of waste tires. Tires are currently processed through the department’s Waste to Energy Facility. During times of plant maintenance, tires cannot be processed. The contract allows for tires to be processed throughout the entire year with no interruptions of service.
