NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Vendor, conducting business as Toilets to Go LLC, with a Federal Tax ID Number of 93-2840544, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. B220607KLB, including appendices and amendments, and Vendor's response.
