

FIRST AMENDMENT OF THE ANNUAL AGREEMENT FOR
RENTAL AND SERVICING OF PORTABLE TOILETS

THIS FIRST AMENDMENT OF THE ANNUAL AGREEMENT FOR RENTAL AND SERVICING OF PORTABLE TOILETS, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and John to Go FL LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the rental and servicing of portable toilets through Solicitation No. B220607KLB with Vendor on the 24th day of February 2023 ("Agreement"); and,

WHEREAS, after the execution it was determined that it would be in the best interest of the County to remove the Restroom Trailers option from the Exhibit B. Fee Schedule of the Agreement; and,

WHEREAS, pursuant to Article XVI. Miscellaneous of the Agreement, the Parties desire to modify the Exhibit B. Fee Schedule to remove the Group 5 - Optional Pricing - Restroom Trailers section of the Fee Schedule table for the Vendor.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. Effective immediately, the Exhibit B. Fee Schedule table shall be superseded by the following:
