1.	Are you looking to replace just the "DEP complaint pump control panel" with the stainless steel nema 4x junction box as I have pictured and nothing else?    DEP COMPLAINT PUMP CONTROL PANEL   PANEL
Answer	As mentioned in the solicitation documents on page 25 under Scope of Work and Specifications item 1.1 states the scope of this project is "to provide 122 Lift Station Control Panels and Junction Boxes complete with all necessary components and provide all materials, equipment, and labor necessary to supply the panels." The codes and specifications that shall be followed are found under section 7 technical specifications. The specific picture in question is found by clicking the link under item 7.1.3 and then clicking 240 Volt, 1 phase with Generator then scroll to page 5 of 13.
2.	I did not see the list of material mentioned in 4. Shop Drawings: list of materials is to be provided by the county.
Answer	As mentioned in the solicitation documents on page 26 under Scope of Work and Specifications section 4 Shop Drawings, the list (also referred by County staff as Bill) of material shall be provided by the manufacturer following County Specs and standards. The list shall include all of the components used in the manufacture of the panels.
3.	What is the accurate address for all panels to be shipped to?

Answer	As mentioned in the solicitation documents on page 26 under Scope of Work and Specifications section 3. Delivery item 3.5 states that "delivery shall include all of Lee County Utilities Facilities as final location will be discussed between Vendor and Department." Prior to final delivery of control panels and junction boxes, the County will designate one of the following locations:  - 7401 College Parkway Fort Myers, FL 33907  - 5180 Tice Street Fort Myers, FL 33905  Final destination for each delivery will be decided by the County.
4.	What type of truck is needed? Do we need a lift gate type of truck for unloading?
Answer	The County has two warehouses that control panels and junction boxes will be delivered to. Both warehouse locations have forklifts for unloading the panels. The type of truck will be up to the Vendor when shipping the control panels and junction boxes and shall be discussed further between Vendor and Department prior to final delivery.
