1.	1.01.A Is this an equipment and installation bid or just equipment only?
Answer	This bid is for equipment/material only. This can be found in the solicitation documents on page 28 under Scope of Work and Specifications, section 7 Technical Specifications, item 7.3 "Installation is not included and shall be completed by County Staff."
2.	1.01.F Are all the equipment to be 277/480 volts, 3 phase?
Answer	As stated in the solicitation documents Revised Attachment A, under Part 1 General, number 1.01 SCOPE OF WORK, item F " <i>The generator Unit shall be as manufactured by Cummins-Onan, or equal, with a standby rating ofkW</i> , <i>kVA, 1800RPM, 0.8 power factor, 277/480Volt, 3 phase, 60 Hertz,4 wire including radiator fan and all parasitic loads.</i> " Please bid as specified.
3.	2.07.D.6 The generator will come with the battery charger mounted within the enclosure, will this be acceptable in lieu of the transfer switch?
Answer	As stated in the solicitation documents Revised Attachment A, under Part 2 Products, number 2.07 AUTOMATIC STARTING SYSTEM, item D 6, "Locate Charger in the automatic transfer switch." Please bid as specified.
4.	2.08.C Is there an HP motor size for each site? How many and will they be starting sequentially? Will the motors have soft starter or it will be across the line starting method?
Answer	Please bid as specified. The HP motor size, quantity, and starting sequence is beyond the scope of this material-only bid

5.	Are there any engineering Riser Diagrams available?
Answer	This solicitation is for materials only, the engineering riser diagrams are not necessary. There are electrical standards plans available on the Lee County Utilities website, however they are not engineering drawings.
