Answer	The specifications, reference to any equipment, material, article or patented process, by trade name, brand name, make or catalog number, shall be regarded as establishing a standard of quality and shall not be construed as limiting competition. If a Vendor wishes to make a substitution in the specifications, the bidder shall furnish to the County, <u>no later than six (6) business days prior to the bid opening date</u>, the name of the manufacturer, the model number, and other identifying data and information necessary to aid the County in evaluating the substitution. Any such substitution shall be subject to County approval through the issuance of a written addendum by the County’s Procurement Management Division. Substitutions shall be approved only if determined by the County to be an <u>Approved Alternate</u> to the prescribed specifications.
