

FIRST AMENDMENT OF THE AGREEMENT FOR
DELIVERY SERVICES FOR LEE COUNTY LIBRARY

THIS FIRST AMENDMENT OF THE AGREEMENT FOR DELIVERY SERVICES FOR LEE COUNTY LIBRARY, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Global Courier Services, Inc. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of delivery services for Lee County Library System through Solicitation No. B230241CMR with Vendor on the 13th day of October, 2023 ("Agreement"); and,

WHEREAS, on September 14, 2024 the South County Regional Library, located at 21100 Three Oaks Parkway, Estero, FL 33928, will be closing for renovations for approximately one year, and a temporary location will be set up at Three Oaks Park, located at 18251 Three Oaks Pkwy, Fort Myers, FL 33912; and,

WHEREAS, the County requires the same delivery services provided for the South County Regional Library at the temporary Three Oaks location, while the South County Regional Library location is under renovation; and,

WHEREAS, to memorialize this change, the Parties desire to modify the Agreement pursuant to Article XIV. MISCELLANEOUS of the Agreement to temporarily change the address for the South County Regional Library courier service location, in the Exhibit A. Scope of Work and Specifications.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The service location address change will begin on the 14th day of September, 2024.
2. The Parties agree the address for South County Regional Library in Section 5. LOCATION'S ADDRESS AND CONTACT INFORMATION of the Exhibit A. Scope of Work and Specifications of the Agreement shall be replaced by the following:

3. The Parties agree that delivery services at the current South County Regional Library location will stop after Friday, September 13, 2024.
4. The Parties agree that delivery services at the temporary Three Oaks Park location shall begin on Monday, September 16, 2024, with no courier services for either location to take place on Saturday September 14, 2024, or Sunday, September 15, 2024.
5. The Parties agree that services for the temporary location shall continue until the renovations at the South County Regional Library have been completed and Lee County Library staff advises to move services back to the original location.
