Dear Mr. Ilesanmi:

On September 29, 2023, Lee County entered into an Agreement with Advanced Nationwide Security Corporation for security guard services to various locations throughout the County, on an as needed basis, before and/or after an emergency or disaster event through Solicitation # B230276LND. Lee County has determined it would be in its best interest to resolicit for these security guard services.

Pursuant to Section XII. Termination, of the Agreement for Security Guard Services – Annual - Federal, the County is exercising its right to terminate the Agreement for convenience. In compliance with the termination procedures established by Section XII, the Agreement shall terminate effective March 21, 2025. Commencing upon the date of this letter, the County is suspending any remaining work by Advanced Nationwide Security Corporation under the Agreement until the termination date of March 21, 2025.
