#### I. MOTION REQUESTED

A) Award Invitation to Bid No. B230384KLB, Population Control Services for Black Spiny-Tailed Iguanas (Ctenosaura Similis) on Gasparilla Island, to Blue Iguana Pest Control, Inc. d/b/a Iguana Control as the primary vendor, and George Cera as the secondary vendor for population control services of Black Spiny-Tailed Iguanas on Gasparilla Island which include the appropriate methods of capture, removal, euthanasia, and disposal, on an as needed basis, for an initial term of one year, as approved in the departments' annual adopted budget.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contracts, for up to three additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewals.

Awards a competitively solicited contract to Blue Iguana Pest Control, Inc. d/b/a Iguana Control as the primary vendor, and George Cera as the secondary vendor for black spiny-tailed iguana population control services on Gasparilla Island, on an as needed basis. The initial term of the contract is one year, with the option for renewal up to three additional years, upon agreement of both parties. Anticipated spend will be \$60,000 annually.
