[10-321(a)] General surface water management (SFWMD ERP)

STIPULATION: Prior to the issuance of a Certificate of Compliance for any project, or any phase of a project, which contains a surface water management system permitted by the South Florida Water Management District (SFWMD), a copy of the executed SFWMD Construction Completion/Construction Certification Form must be submitted to this office.

[10-329(c)(5)] Dewatering. Neither applied for or approved.

STIPULATION: Should dewatering become necessary, this approval must be amended to authorize dewatering.

10-329(d)(8)a.] Excess Spoil Removal. Staff understands that the 38,500+- CY of excavated material will be stockpiled on site and not removed from the site at this time.

STIPULATION: An excess spoil removal plan must be reviewed and approved prior to removal of any excavated material from the site.
