On April 18, 2024, Lee County entered into an Agreement with Swift Print Service, Inc. to purchase printing services on an as needed basis. Lee County was recently advised that Swift Print Service, Inc. had sold their assets to Print 1 Group, LLC, effective June 12, 2026. On July 14, 2026, Print 1 Group advised Lee County they could not maintain the agreed upon pricing for printing services established by the April 18, 2024 Agreement between Lee County and Swift Print Service, Inc. and requested termination of that Agreement.

Therefore, pursuant to Section XII. Termination of the Agreement between Lee County and Swift Print Service, Inc. the County is exercising its right to terminate the Agreement for convenience. In compliance with the termination procedures established by Section XII, the Agreement shall terminate as of August 14, 2026. Commencing upon the date of receipt of this Notice, the County is mandating a suspension of any remaining work under this Agreement.

Thank you for reaching out regarding your question of moving under the Print 1 Group umbrella. The good news is, changing your entity via merger, sale, and/or assignment would not necessitate termination of your contract. Typically, the way it works is the new entity, whatever it may be, assumes the contract we had entered into under the same terms and conditions as agreed to. Once your entity change is completed, we will need to set you up in our payment system under the new entity information by having you submit the required new vendor application documents, like you did when you first registered with Lee County- here:

Then, we will prepare an amendment to the printing contract assigning the contract from Swift Print to whatever the new entity name is.
