SECOND AMENDMENT OF THE AGREEMENT FOR SUPPLY OF ROCK, AGGREGATE,  
SCREENINGS, SAND, AND OTHER RELATED MATERIALS – ANNUAL

THIS SECOND AMENDMENT OF THE AGREEMENT FOR SUPPLY OF ROCK,  
AGGREGATE, SCREENINGS, SAND, AND OTHER RELATED MATERIALS – ANNUAL  
is made and entered into by and between the Lee County Board of County Commissioners, a  
political subdivision of the State of Florida ("County") and Grippe Pavement Maintenance Inc.  
("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement to purchase rock, aggregate,  
screenings, sand, and other related materials through Solicitation No. B240104KCW with Vendor  
on the 29<sup>th</sup> day of May, 2024 ("Agreement"); and,

WHEREAS, Solicitation No. B240104KCW was awarded to a pool of vendors who were  
categorized as 'Primary,' 'Secondary,' and 'Tertiary,' for each product, based upon their bid; and,

WHEREAS, after the execution of the Agreement, all other vendors' agreements, besides  
Grippe Pavement Maintenance Inc., have expired, without exercising their renewal option; and,

WHEREAS, the 'Primary,' 'Secondary,' and 'Tertiary,' designation for each product needs  
to be updated, as Vendor, Grippe Pavement Maintenance Inc. will now be the only remaining  
vendor on the Agreement; and,

WHEREAS, the Parties mutually agree that the changes in designations of 'Primary,'  
'Secondary,' and 'Tertiary,' will begin on the 21<sup>st</sup> day of May 2026; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV.  
MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL  
COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

- The Parties agree that effective the 21<sup>st</sup> day of May 2025, Vendor, Grippo Pavement Maintenance Inc. will be the only remaining vendor on the Agreement, making them the Primary vendor for all items, and the following Fee Schedule shall supersede the existing Fee Schedule in Exhibit B of the Agreement:
