I. MOTION REQUESTED

A) Approve Amendment No. 1 to the contract with P & T Lawn & Tractor Service, Inc, under Solicitation No. B240118WCD, Landscape Maintenance & Mowing-Parks-Annual, to add additional landscape services for the Ruby Gill House Park. The amendment will increase the contract amount by \$8,000.00 annually, with total anticipated expenditures in the amount of \$1,108,000.00. Amount is included in the budget.

B) Authorize the County Manager or designee to execute the amendment on behalf of the Board of County Commissioners.

II. ITEM SUMMARY

Approves amending the contract with P & T Lawn & Tractor Service, Inc. to add additional landscape services for the Ruby Gill House Park. The amendment will increase the contract amount by \$8,000.00 annually, with total anticipated expenditures in the amount of \$1,108,000.00. Amount is included in the budget.

A) Board Action and Other History

On May 7, 2024 the Board of County Commissioners awarded B240118WCD, Landscape Maintenance & Mowing-Parks-Annual, to P & T Lawn & Tractor Service, Inc. to provide landscape maintenance of ninety-one Parks and Recreation locations, on an as-needed basis. The original term of the contract was for 3-years with an option to renew for up to 2 additional years.

On May 7, 2024, The Board approved the termination of the Lease Agreement between Lee County and the University of Florida. The Ruby Gill House Park property was subsequently turned back over to the Parks and Recreation Department.
