There may be an option to extend this contract as specified in the Scope of Work or specifications upon the approval of both the County and the Vendor at the time of extension or renewal for up to three (3), additional one (1) year periods.

delivery requirements and estimated amounts can be found in sections 2.5, 3, and 6 of the Scope of Work and Specifications, which begins on page 18 of the solicitation package.
