SECOND AMENDMENT OF ANNUAL AGREEMENT FOR SODIUM HYPOCHLORITE FOR WATER & WASTEWATER FACILITIES

THIS SECOND AMENDMENT OF THE ANNUAL AGREEMENT FOR SODIUM HYPOCHLORITE FOR WATER & WASTEWATER FACILITIES made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Allied Universal Corp. ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of sodium hypochlorite solution through Solicitation B240206CFC with Vendor on the 8th day of August, 2024 ("Agreement"); and,

WHEREAS, the Parties mutually agree to increase the rate for the purchase of sodium hypochlorite solution from the Vendor, to be effective the 1st day of September 2026; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XV. MISCELLANEOUS of the Agreement to increase the rate for the purchase of sodium hypochlorite solution from the Vendor.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The Parties agree that, effective the 1st day of September 2026, the following Fee Schedule table shall supersede the existing Fee Schedule table in Exhibit B of the Agreement:
