**I. MOTION REQUESTED**

- A. Award Invitation to Bid No. B250032AVR Sandblasting & Industrial Coating Annual to Clean Infusion LLC, DLR Mobile Repairs, Inc.; Five 12 Painting & Remodeling, LLC; Paints & Coatings, Inc; Quick Painting Group; Razorback, LLC; Restoration & Protective Solutions; Vulcan Construction and Metal Works for the Sandblasting and Industrial Coating on an as-needed basis, for an initial term of three years, as approved in the departments' annual adopted budgets.
- B. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C. Grant the County Manager or designee the authority to renew the contracts for up to two additional years and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County.

**II. ITEM SUMMARY**

Awards competitively bid contracts to eight companies for annual sandblasting and industrial coating, to provide and perform protective coating services on an as-needed basis for an initial term of three years with an option to renew for up to two additional years. This contract is used to provide all labor, materials and equipment for sandblasting and industrial coating services as approved in the departments' annual adopted budgets. Individual projects in excess of \$100,000.00 will be presented to the Board for approval. Expenditures for these services in FY24 were \$535,177.00 by the Utilities department. The companies are as follows:

- Clean Infusion LLC
- DLR Mobile Repairs, Inc.
- Five 12 Painting & Remodeling, LLC
- Paints & Coating, Inc.
- Quick Painting Group
- Razorback, LLC
- Restoration & Protective Solutions
- Vulcan Construction and Metal Works

**III. BACKGROUND AND IMPLICATIONS OF ACTION**

Procurement Management obtained bids for the project known as Invitation to Bid No. B250032AVR, Sandblasting and Industrial Coating - Annual, Procurement Management received 8 submittals. After conducting an analysis of the bid submissions, the determination was made to award to all eight vendors: Clean Infusion LLC, DLR Mobile Repairs, Inc., Five 12 Painting & Remodeling, LLC; Paints & Coating, Inc.; Quick Painting Group; Razorback, LLC; Restoration & Protective Solutions; Vulcan Construction and Metal Works as they are responsive and responsible bidders. Staff recommends awarding a contract to all 8 vendors for use on an as-needed basis for an initial three-year term, with the option to renew for up to two additional years.
