**TITLE:** Award Countywide Annual Contract for Paint with Related Supplies and Equipment

**I. MOTION REQUESTED**

- A. Award Invitation to Bid No. B250296JAK, Paint with Related Supplies and Equipment to Florida Paints & Coatings, LLC and The Pittsburgh Paints Co for paint, paint-related supplies, and paint equipment on an as-needed basis, for an initial term of three years, as approved in the departments' annually adopted budgets.
- B. Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C. Grant the County Manager or designee the authority to renew the contracts for up to three additional years, and to execute all associated documents, as approved in the departments' annually adopted budgets, if doing so is in the best interest of Lee County.

**II. ITEM SUMMARY**

Awards competitively bid countywide contracts for paint with paint-related supplies and equipment to Florida Paints & Coatings, LLC and The Pittsburgh Paint Co. on an as-needed basis as approved in departments' annually adopted budgets. The contracts will have an initial term of three years with the option to renew for up to three additional years. Total expenditures for these services during Fiscal Year 2024-2025 were \$39,187.51 by the Facilities, Parks and Recreation, Transportation, and Utilities departments.

**III. BACKGROUND AND IMPLICATIONS OF ACTION**

Procurement Management obtained bids on behalf of the Board of County Commissioners for the project known as Invitation to Bid No. B250296JAK, Paint with Related Supplies and Equipment. On the bid deadline of September 9, 2025, Procurement Management received two submittals. After conducting an analysis on the bid submissions, staff recommends making an award to the two vendors that were found responsive and responsible.

Paint with related supplies and equipment is required by various departments on an as-needed basis throughout the year. Total expenditures for these services during Fiscal Year 2024-2025 were \$39,187.51.
