Pursuant to a written submitted question, the following clarification is issued for the referenced solicitation:

- 1) Section: Services Special Conditions, F. Proposal Performance & Payment Bond. Page: 12.
Question: This section references a proposal security bond that is to be submitted with the final proposal. Since this proposal requires on-call professional services (which typically don't require bonds), can the City confirm whether a bid bond is required for this contract?

ANSWER: A Proposal Performance & Payment Bond is NOT required for this Request for Proposal.

- 2) I have a question regarding RFP #16-014. Our company, typically, does not provide performance bonds due to the fact that we have no subcontractors. The RFP states that this is a requirement. We can provide a surety bond, but we would like to know how long those funds would be held after being received.
