

FIRST AMENDMENT OF PROFESSIONAL SERVICES AGREEMENT
FOR LANDSCAPE ARCHITECTURAL SERVICES

THIS FIRST AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR LANDSCAPE ARCHITECTURAL SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and RVi Planning + Landscape Architecture, Inc. ("Consultant"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of Landscape Architectural Services through Solicitation CN180324TJM with Consultant on the 8th day of October, 2018 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Consultant's business entity name was Waldrop Engineering, P.A., with a Federal Tax ID Number of 59-3656041; and,

WHEREAS, after execution of the Agreement, Waldrop Engineering, P.A.'s parent company was acquired by Atwell, LLC and Waldrop Engineering, P.A. is now a wholly owned subsidiary of Atwell, LLC, with a Federal Tax ID Number of 27-1219822 and of which RVi Planning + Landscape Architecture, Inc., with a Federal Tax ID Number of 74-2546670, also is a subsidiary; and,

WHEREAS, County and Consultant desire to enter into this First Amendment to continue their Agreement via Solicitation No. CN180324TJM under the Consultant's new business name.






