#### I. MOTION REQUESTED

- A) Award Competitive Negotiation Request for Proposal No. CN180442GWT, Materials Testing Services Countywide to the following vendors for a period of one year, to provide countywide materials testing services, as approved in the departments' annual adopted budgets: American Management Resources Corporation; Ardaman & Associates, Inc.; ECS-Florida, L.L.C.; GFA International, Inc.; HighSpans Engineering, Inc.; Nova Engineering and Environmental, LLC.; Universal Engineering Sciences, Inc. and Velocity Engineering Services, LLC.
- B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
- C) Grant the County Manager or designee the authority to negotiate renewals of the contracts, including changes in price, for up to three additional one-year periods, and/or to extend the contracts up to six months, and to execute all associated documents, with County Administration approval, as approved in the departments' annual adopted budgets, if doing so is the best interest of Lee County.

#### II. ITEM SUMMARY

Awards contracts for miscellaneous material testing services for constructions projects - countywide to: American Management Resources Corporation; Ardaman & Associates, Inc.; ECS-Florida, L.L.C.; GFA International, Inc.; HighSpans Engineering, Inc.; Nova Engineering and Environmental, LLC.; Universal Engineering Sciences, Inc. and Velocity Engineering Services, LLC, for an initial period of one year with the option to renew for three additional one-year periods. Total expenditures for these services during Fiscal Year 2017 – 2018 were approximately \$44,265.25.

#### III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

Lee County Procurement Management advertised CN180442GWT Materials Testing Services on August 7, 2018, for qualified vendors to provide materials testing services on behalf of the Board of County Commissioners. On the proposal deadline of September 5, 2018, Procurement Management received eight proposals. The evaluation committee met on September 24, 2018 and short-listed all eight vendors to give presentations. The second evaluation meeting was held on October 9, 2018, and after the meeting the committee recommends awarding contracts to all eight vendors: American Management Resources Corporation; Ardaman & Associates, Inc.; ECS-Florida, L.L.C.; GFA International, Inc.; HighSpans Engineering, Inc.; Nova Engineering and Environmental, LLC.; Universal Engineering Sciences, Inc. and Velocity Engineering Services, LLC.

Total expenditures for these services during Fiscal Year 2017 – 2018 were approximately \$44,265.25.
