

FIRST AMENDMENT OF PROFESSIONAL SERVICES AGREEMENT

THIS FIRST AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR MISCELLANEOUS ARCHITECTURAL SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Grace Hebert Curtis Architects, LLC ("Consultant"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of miscellaneous architectural services through Solicitation CN190407BAG with Consultant on the 24th day of February, 2020 ("Agreement"); and,

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Consultant, conducting business as Grace Hebert Curtis Architects, LLC, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. CN190407BAG, including appendices and amendments, and Consultant's response.
