

FIRST AMENDMENT OF PROFESSIONAL SERVICES AGREEMENT

THIS FIRST AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR MISCELLANEOUS PROFESSIONAL SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Bowman Gulf Coast LLC dba Hole Montes, a Bowman Company ("Consultant"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of miscellaneous professional services through Solicitation CN200224JJB with Consultant on the 16th day of December, 2020 ("Agreement"); and,

WHEREAS, on the date the Agreement was executed, the Consultant's business entity name was Hole Montes, Inc., with a Federal Tax ID Number of 59-1518838; and,

WHEREAS, after execution of the Agreement, Hole Montes, Inc. was acquired by Bowman Gulf Coast LLC, and began operating as Bowman Gulf Coast LLC dba Hole Montes, a Bowman Company, with a Federal Tax ID Number of 92-2421024; and,

WHEREAS, County and Consultant desire to enter into this First Amendment to continue their Agreement via Solicitation No. CN200224JJB under the Consultant's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:
