TITLE: Award Contract for Miscellaneous Traffic Engineering Services - Countywide

I. MOTION REQUESTED

A) Award Competitive Negotiation Request for Proposal No. CN210187BAG, Miscellaneous Traffic Engineering Services to provide professional traffic engineering consulting services, on an as needed basis, for an initial term of three years, as approved in the departments' annual adopted budget. Contracts have been negotiated with the following vendors: Cardno, Inc., David Plummer & Associates, Inc., Florida Transportation Engineering, Inc., Gannett Fleming, Inc., Kissinger Campo & Associates Corp., McCormick Taylor, Inc., Stantec Consulting Services, Inc., TR Transportation Consultants, Inc., and Tindale Oliver & Associates, Inc. Individual projects in excess of \$100,000.00 will be presented to the Board for approval.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contracts, for up to three additional years, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewals.

II. ITEM SUMMARY

Awards competitively solicited contracts to provide professional traffic engineering consulting services. There were twenty-seven proposals submitted and contracts were negotiated with the following nine vendors: Cardno, Inc., David Plummer & Associates, Inc., Florida Transportation Engineering, Inc., Gannett Fleming, Inc., Kissinger Campo & Associates Corp., McCormick Taylor, Inc., Stantec Consulting Services, Inc., TR Transportation Consultants, Inc., and Tindale Oliver & Associates, Inc. The initial contracts will be for a term of three years with the option to renew for up to three additional years. Individual projects in excess of \$100,000.00 will be presented to the Board for approval.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

Lee County Department of Transportation submitted a request to Procurement Management to obtain proposals for the project known as CN210187BAG Miscellaneous Traffic Engineering for professional traffic engineering services on an as needed basis. On the proposal deadline of April 6, 2021, Procurement Management received twenty-seven proposals. The Competitive Negotiations Committee meeting was held on Friday, May 21, 2021, during which the Evaluation Committee considered criterion listed in the solicitation: qualifications of firm, company relevant experience & reference, firm plan of approach, and personnel being proposed. Eleven firms were short-listed.

Interviews were conducted on Friday, June 18, 2021. The final evaluation meeting was held, after the scheduled interviews, on Friday, June 18, 2021. The committee recommended awarding contracts to nine firms: Cardno, Inc., David Plummer & Associates, Inc., Florida Transportation Engineering, Inc., Gannett Fleming, Inc., Kissinger Campo & Associates Corp., McCormick Taylor, Inc., Stantec Consulting Services, Inc., TR Transportation Consultants, Inc., and Tindale Oliver & Associates, Inc.
