Dear Mr. Stoker:

On September 1, 2021, Lee County entered into an Agreement with Cardno, Inc. for Miscellaneous Traffic Engineering Services, Contract No. 9174. Lee County was recently advised that Cardno, Inc. had merged with, and begun operating as, Stantec Consulting Services, Inc. and would be performing all future work under the existing Stantec Consulting Services, Inc. Miscellaneous Traffic Engineering Services agreement, Contract No. 9180.

Therefore, Pursuant to Article 21.00, Termination, of Contract No. 9174, the County is exercising its right to terminate Contract No. 9174 for convenience. In compliance with the termination procedures established by Article 21, the Contract shall terminate as of February 10, 2023. Commencing upon the date of receipt of this Notice, the County is mandating that any remaining work under Contract No. 9174 shall now be performed under the Cardno, Inc. contract, No. 9180.
