1. ARTICLE REVISIONS

CONSULTANT SERVICES: The Consultant Services Section, Article 3.2 on page 15 shall be revised as follows:

3. CONSULTANT SERVICES

- 3.2. CONSULTANT shall provide all programming, design, permitting, construction documents, and construction administration to demolish the current Natural Resources Lab and replace it with a new two story 10,000 sq. ft lab.
 - 3.2.1. Pending further investigation and as deemed in its best interests, the County reserves the right to proceed with the following options:
 - 3.2.1.1. Continue with demolishing the current Natural Resources Lab but relocating it to another site as determined by the County; or
 - 3.2.1.2. Continue with demolishing the current Natural Resources Lab but removing the option of building a new Natural Resources Lab at the current site or any potential location as determined by the County.
 - 3.2.2. Option chosen will be at the discretion of the County and communicated to the CONSULTANT prior to design.
