- 1. Paragraph 1.2 of the Detailed Specifications section of Solicitation No. CN230067NAT, which was incorporated into the Agreement, shall be superseded by:
- "1.2. CONSULTANT will be responsible for providing complete engineering services for a wide range of projects or systems, which may include but not be limited to single and multi-story facilities, roadways, bridge(s) and over passes, roofing systems, sea walls, weirs, retaining walls, etc."
