WHEREAS, GradyMinor and its employees have now fully integrated into, and are operating as, Pape-Dawson Consulting Engineers, LLC, with the Federal Tax ID Number of 74-1676252; and,

WHEREAS, County and Consultant desire to enter into this Second Amendment to continue their Agreement via Solicitation No. CN230221CMR under the Consultant's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Consultant, conducting business as Pape-Dawson Consulting Engineers, LLC, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. CN230221CMR, including appendices and amendments, and Consultant's response.
