

FIRST AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR MISCELLANEOUS PROFESSIONAL SERVICES

THIS FIRST AMENDMENT OF THE PROFESSIONAL SERVICES AGREEMENT FOR MISCELLANEOUS PROFESSIONAL SERVICES, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Pape-Dawson Consulting Engineers, LLC ("Consultant"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of miscellaneous professional services through Solicitation CN250266KLB with Q. Grady Minor and Associates, LLC, with a Federal Tax ID Number of 59-2583954, ("GradyMinor") on the 11th day of December, 2025 ("Agreement"); and,

WHEREAS, on the date that GradyMinor had submitted their proposal in response to the County's Solicitation CN250266KLB, GradyMinor had recently been acquired by Pape-Dawson Consulting Engineers, LLC, and was in the process of integrating into the new entity; and,

WHEREAS, by the time the Agreement was executed, GradyMinor had fully integrated into, and were operating as Pape-Dawson Consulting Engineers, LLC, with the Federal Tax ID Number of 74-1676252; and,

WHEREAS, County and Consultant desire to enter into this First Amendment to continue their Agreement via Solicitation No. CN250266KLB under the Consultant's new business name.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

Consultant, conducting business as Pape-Dawson Consulting Engineers, LLC, shall continue to supply such products and services in accordance with the terms, conditions, and specifications of the Agreement, via Solicitation No. CN250266KLB, including appendices and amendments, and Consultant's response.

IN WITNESS WHEREOF, this First Amendment of the Agreement has been signed and sealed, in duplicate, by the respective parties hereto. Each individual signing this Amendment directly and expressly warrants that he/she has been given and has received and accepted authority to sign and execute the Amendment on behalf of the party for whom it is indicated he/she has signed, and further has been expressly given and received and accepted authority to enter into a binding amendment on behalf of such party with respect to the matters contained herein and as stated herein.




