## **ACTION REQUESTED:**

A. Approve Piggyback No. PB170221KLC allowing the County to utilize pricing on National Intergovernmental Purchasing Alliance Contract No. R161701 with Anixter Inc. for Cabling and Networking Products & Solutions, which went through their competitive bid process (RFP# 16-17), for the purchase of electrical supplies countywide on an as-needed basis as approved in the departments' annual adopted budgets.
