Answer	Please see the answer on Addendum 1 question number 3. Forms 6 and 7 have been updated and attached to Addendum 1.

2.	Tab 2 (Page 18) – Company Relevant Experience & Reference. We are to submit a maximum of 3 projects similar in scope and size. Do the projects need to be completed projects? Can the reference forms be for those 3 projects? Can the reference form be for projects completed in the last 12 months or can they be for any project regardless of completion date? Can we use Lee County projects for references?
Answer	Yes, the projects must be completed projects. Yes, the reference forms may be for the projects submitted as relevant experience projects. The reference form may be for projects completed within the last 12 months or any date previously. Lee County references are not preferred; however, may be utilized if consultant does not have other client/references to present.

3.	Forms 6 (page 30) Sub-Contractor/Consultant List. Form is cut off on the right margin please repost that page.

4.	Form 7 (page 31) Public Entity Crime Form. Form is cut off on the right margin, please repost that page.

5.	Form 8 (page 33) minimum qualification requirements. Does this form need to be completed for the subconsultants also? Do we need to include the Florida DOT Pre-

	Qualification letter for both the Prime. Do we need to include the Florida DOT Pre-Qualification letter for the all the subconsultants?
Answer	Please see special conditions number 2 for FDOT Prequalification requirements. FDOT prequalification should be provided for the Prime and all sub-consultants to satisfy this requirement. Verification of FDOT Prequalification should be included with your submission. The inclusion of this verification will not count towards the proposal page count.
6.	Has the County had any advance coordination with any regulatory agencies regarding the bridge replacement?
Answer	No, the County has not had any advance coordination with any regulatory agencies regarding the bridge replacement.
7.	Would the County be able to provide the as-built plans for the existing bridges, roadway, toll plaza, lighting, signing & pavement markings, and intelligent transportation system (ITS)?
Answer	The Consultant that is awarded the project will receive plans, etc... Additionally, please refer to the answer to question 4 on Addendum 1.
8.	Are the signalized intersections of Del Prado Boulevard and South Pointe Boulevard anticipated to be included in the project limits and the proposed improvements to alleviate congestion?
Answer	The project limits will be determined as part of the analysis and design.
9.	Regarding 16.1. The use of sub-Proposer/consultant under this solicitation is not allowed without prior written authorization from the County representative. Do our subconsultants have to be pre-approved before submittal of the LOI? If yes, how do we get that pre-approval?
Answer	Sub-consultants may be utilized under this solicitation and do not need to be approved by the County prior to the submission of the proposal. However, please review Form 8: Minimum Qualification Requirements in regards to sub-CONSULTANT Criteria 2 - FDOT Prequalification (Minor Work Group).
10.	Are original "wet" signatures required on all forms or will electronic signatures suffice?
Answer	Electric signatures on bid submissions are acceptable.
11.	For the reference survey, the reference itself can be a max of 12 months old, however, the reference project doesn't need to have been completed in the last 12 months, correct?
Answer	Please see the answer to question number 2. The reference form can be for projects completed within the last 12 months or any date previously.
12.	Is it acceptable to include a cover letter with our submittal? Would that need to be included in the 10 page limit.
Answer	Yes, a cover letter will be acceptable with your submission. The cover letter does not count toward the 10 page limit.
