TITLE: Award Annual Contract for Class III Contingency Solid Waste Disposal

I. MOTION REQUESTED

A) Award Invitation to Bid No. B230230MWB, to A.C.M.S. Inc. dba Heart of Florida Environmental for Class III Contingency Solid Waste Disposal Services, on an as-needed basis, for an initial term of three years, in the amount of \$250,000.00 per year. Individual purchases in excess \$100,000.00 will be presented to the Board for approval.

B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.

C) Grant the County Manager or designee the authority to renew the contract for up to three additional years and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewal(s).

II. ITEM SUMMARY

Awards a Contract to A.C.M.S. Inc., dba Heart of Florida Environmental, for contingency solid waste disposal services in the amount of \$250,000, a not-to-exceed annual amount. The initial term is for three years, with up to a single three-year extension period as mutually agreed.

During unplanned outages to Lee County disposal facilities, or when incoming waste volumes exceeds internal processing or disposal capacity, Lee County sends Class III waste (including construction and demolition residue) to an outside permitted landfill for disposal. The contingency disposal contract will provide a reliable backup to internal disposal.

III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

Procurement Management solicited bids for the project known as Bid No. B230230MWB, Class III Contingency Solid Waste Disposal Services. On the bid solicitation deadline of September 6, 2023, Procurement Management received three submissions, including one No Bid. After conducting an analysis of the bid submissions, staff recommends awarding to A.C.M.S. Inc., dba Heart of Florida Environmental.

This contract is for use on an as-needed basis for an initial term of three-years with mutually-agreed renewal not to exceed the three years, in increments as mutually agreed. This is a new annual contract for Lee County. Disposal will be in a FDEP permitted facility in Sumter County.
