TITLE: Award Contract for Contingency Solid Waste Transfer Hauling and Disposal

### I. MOTION REQUESTED

- A) Award Invitation to Bid No. B200128DWJ, Contingency Solid Waste Transfer Hauling and Disposal to primary vendor Wherry Truck Lines, Inc. and secondary vendor Fleet Express Lines, Inc. for solid waste transfer hauling and unloading services from County operated Solid Waste facilities, on an as needed basis, for an initial term of one-year, in the amount of \$100,000.00.
- B) Authorize the Chair to execute the contract documents on behalf of the Board of County Commissioners.
  C) Grant the County Manager or designee the authority to renew the contracts, for up to three additional one-year periods, and to execute all associated documents, as approved in the departments' annual adopted budgets, if doing so is in the best interest of Lee County, and there are no cost increases associated with the renewals.

#### II. ITEM SUMMARY

Contracts with primary vendor Wherry Truck Lines and secondary vendor Fleet Express Lines to provide contingency solid waste tractortrailer transfer services from Solid Waste facilities to approved disposal sites on an as needed basis. Contingency hauling services are used when abnormally high volumes of waste materials are received or when mechanical failures take department equipment offline. Contingency transfer services ensures waste is managed in a timely manner and in compliance with the department's permitted conditions. A purchase order was issued for associated expenditures in Fiscal Year 2018-2019 in the amount of \$48,375.00.

### III. BACKGROUND AND IMPLICATIONS OF ACTION

A) Board Action and Other History

Procurement Management obtained bids for the project known as Invitation to Bid No. B2002128DWJ, Contingency Solid Waste Transfer Hauling and Disposal. On the bid deadline of March 16, 2020, Procurement Management received three submittals. After conducting an analysis of the bid submissions, Wherry Truck Lines, Inc. was awarded as primary vendor and Fleet Express Lines, Inc. was awarded for secondary vendor.

Staff recommends awarding contracts to Wherry Truck Lines, Inc. and Fleet Express Lines, Inc. for use on an as-needed basis for an initial one-year period in the amount of \$100,000.00.
