**RE: B200128DWJ- CONTINGENCY SOLID WASTE TRANSFER HAULING
AND DISPOSAL – NOTICE TO CANCEL RENEWAL**

Dear Mr. Wherry,

On June 17th, 2020, Lee County entered into an agreement with Wherry Truck Lines, Inc. to purchase contingency solid waste transfer hauling and unloading services from County operated Solid Waste facilities, under Solicitation No. B200128DWJ. On October 20, 2022, Wherry Truck Lines, Inc. agreed to a renewal of the agreement for another 1-year term.

After receipt of Wherry Truck Lines, Inc.'s signed renewal letter, Lee County reevaluated its needs under the Contingency Solid Waste Transfer Hauling and Disposal agreement and determined it would be in the County's best interest to re-bid the annual agreement. Therefore, the County will not be completing the renewal of the Contingency Solid Waste Transfer Hauling and Disposal agreement, under Solicitation No. B200128DWJ, but does invite Wherry Truck Lines, Inc. to re-bid under the new Solicitation once it is advertised.

The current Contingency Solid Waste Transfer Hauling and Disposal agreement, under Solicitation No. B200128DWJ will expire at the conclusion of the current term, on June 1, 2023.
