PRICING

This is a “Master” contract, which is not for any specific project. Work will be negotiated, authorized, scheduled, funded, and accounted for by the issuance of County Project Authorizations (CPA), by the requesting department, division or other governmental entity. The County’s intent is to award to a pool of vendors who meet the minimum criteria and qualifications.

1. **Each project/task order will not exceed \$400,000.00.**
 - 1.1. Any project/task order **\$25,000.00 or less** may be awarded to the vendor holding a valid contract under this bid, with the lowest unit prices, able to meet the required schedule.
 - 1.2. Any project/task order **\$25,000.01, but less than \$200,000.01** shall be quoted by a **minimum of 3 awarded vendors** holding a valid contract under this Bid.
 - 1.3. Any project/task order **over \$100,000.00** must provide a payment and performance bond.
 - 1.4. No vendor will be paid more than **\$2,000,000.00 per year**.
 - 1.5. The County retains the right to select any vendor to whom a multiple-vendor award has been made.
 - 1.6. The County retains the right to separately and competitively bid any and all job estimates **greater than \$200,000.00**.
