

SECOND AMENDMENT OF AGREEMENT FOR  
ROOFING SERVICES FOR LEE COUNTY

THIS SECOND AMENDMENT OF THE AGREEMENT FOR ROOFING SERVICES FOR LEE COUNTY, made and entered into by and between the Lee County Board of County Commissioners, a political subdivision of the State of Florida ("County") and Service Works of Ft. Lauderdale, LLC ("Vendor"), collectively, the "Parties."

WHEREAS, the County entered into an Agreement for the purchase of roofing services for Lee County, through Solicitation Number RFP170382ANB with Vendor on the 13<sup>th</sup> day of November, 2017, ("Agreement"); and,

WHEREAS, Exhibit A, Scope of Services to the Agreement establishes any project/task with a total cost of \$25,000.01, but less than \$400,000.00 shall be quoted by a minimum of three (3) of the approved firms holding a valid contract under Solicitation No. RFP170382ANB; and,

WHEREAS, it was discovered after the execution of the Agreement, that it would be in the best interest of the County for the County to retain the right to have tasks/projects with a total cost of more than \$200,000.00 be separately and competitively bid outside of Solicitation No. RFP170382ANB; and,

WHEREAS, the Parties desire to modify the Agreement pursuant to Article XVII. MISCELLANEOUS of the Agreement.

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING AND THE MUTUAL COVENANTS CONTAINED HEREIN, IT IS AGREED AS FOLLOWS:

1. The clause “Any project/task with a total cost of **\$25,000.01, but less than \$400,000.00** shall be quoted by a **minimum of three (3) of the approved firms** holding a valid contract under Solicitation No. RFP170382ANB.” in Exhibit A Scope of Services, Award of County Project Authorizations section shall be superseded by: “Any project/task with a total cost of **\$25,000.01, but less than \$200,000.01** shall be quoted by a **minimum of three (3) of the approved firms** holding a valid contract under Solicitation No. RFP170382ANB.”
  
2. The Parties agree that the Scope of Services in Exhibit A of the Agreement shall be supplemented by the following clause:  
“The County retains the right to separately and competitively bid any and all projects/tasks with a total cost of **\$200,000.01 or more**, outside of Solicitation No. RFP170382ANB.”


